TERMS AND CONDITIONS

- A. - I. The Publisher of the Conference Programme, the Organisers, Sponsors, Montgomery, its Agents or Employees will not be responsible for any errors or omissions on copy prepared and submitted by the Advertiser or Participant.
- J. The signature of the Application Form and its receipt by Montgomery is deemed conclusive evidence of the Applicant's agreement to pay the full fees due from that moment. Furthermore, Montgomery, will not be responsible and will be held harmless should any conflicts or misinterpretations arise with the host county, its sponsors, agents or other bodies regarding any and all aspects of the Conference which may affect the Participants. The said Participant acknowledges that Montgomery have sustained damages and losses as a result of the foregoing, as well, and shall and does hereby waive all claims for damages or compensation.
